# 2. MINUTES OF THE LAST AGM

#### 3. ESA AGM 2021 President's Remarks

#### Andrew Mackenzie said:

"Covid 19 has created another challenging year with no in-person fundraising events so far. However, this year we have got back to fundraising and giving out money to good causes.

After welcoming applications in May, the committee decided to donate funds to the Sutherland Care Forum, Brora Primary Parent Council and Big Sing in Skerray. We also donated to some young folk in the county, Lewis Duncan from Brora and Ruaraidh Jack from Bettyhill. Therefore, in total, the committee agreed to donate £2,500 to good causes in Sutherland.

That has only been possible due to fundraising. We held a Zoom event on 22 November with renowned Brora photographer, Craig Mackay, raising over £300. We have also benefited from donations, including from our Patron, David Morrison. This year we also developed a particularly special fundraising partnership with the now record-breaking, Robbie Mitchell. Robbie, from Durness, raised over £4,000 for the Association with his incredible North Coast 500 cycle challenge in the summer. We hope to work with Robbie again in the future.

I am delighted that we will hold an in-person event later this week – our Christmas dinner on 4 December. It will be a small gathering of around 22 people but will be a great opportunity to meet in person after almost two years without much face-to-face contact.

I will take this opportunity to thank all the committee, and particularly Anne and Steven, for their hard work over the year."

## 4. TREASURER'S REPORT

At the end of April 2021 we had a balance of £3,102.35 in the current account and £3,020.52 in the NS & I, making a total of £6122.87 - compared to £3,904.16 last year.

The balance at present 29/11/21, in the Current Account, is £5,653.96 and the national savings £3,020.52, making a total of £8,674.48

Our only Fund Raising for the year was the Virtual Ceilidh which raised £727.
